About Police, Fire and Crime Commissioners

On 2nd May, you will be able to vote for your Police, Fire and Crime Commissioner (PFCC). The role of the PFCC is to be the voice of the people and hold the police and fire and rescue service to account.

Police, Fire and Crime Commissioners (PFCCs) are elected to hold the police force and fire and rescue service to account for delivering the kind of policing and fire and rescue service you want to see. In addition to their role overseeing the police, a PFCC is also the Fire and Rescue Authority (FRA) for their area. PFCCs bring a public voice to policing and the fire and rescue service and they do this by:

- Engaging with the public and victims of crime to help set police and crime plans;
- Setting the fire and rescue objectives for their area through a fire and rescue plan;
- Ensuring the police force and fire and rescue service budgets are spent where it matters most; and
- Appointing the chief constable and chief fire officer, holding them to account for delivery of their objectives and if necessary, dismissing them.

PFCCs are responsible for both the police force and the fire and rescue service within their area and are responsible for delivering efficient and effective services.

The PFCC does not "run" the police force or the fire service. Chief constables and chief fire officers continue to be responsible for the day-to-day operations of the police force and fire service respectively, but they are accountable to the public via the PFCC.

In some Police Force Areas, a Police and Crime Commissioner (PCC) is elected instead – this is similar to a PFCC, but is only responsible for the police force in their area – they are not the FRA for their area. Furthermore, in some areas, neither a PCC nor PFCC is elected – instead there will be an election for a Mayor who will hold the PCC, PFCC or equivalent powers.

37 PCCs will be elected across England and Wales, of which 4 will be PFCCs – PFCCs are found in Cumbria, Essex, Staffordshire, and Northamptonshire.

Work with others

PFCCs also work with your council and other organisations to promote and enable joined up working on community safety and criminal justice. As directly elected individuals, they provide opportunities for greater collaboration and effective scrutiny of public services. In doing so, PFCCs also have regard to national cross border threats, and ensure there is an effective policing response.

With a single directly elected individual overseeing both police and fire and rescue services, there are greater opportunities for blue light collaboration.

Represent the entire community

PFCCs are required to swear an oath of impartiality when they are elected to office. The oath is designed so that they can publicly set out their commitment to: serve all of the people in their Police Force Area; act with integrity and diligence; give a voice to the public; act with transparency so that they may be effectively held to account; and not interfere with the operational independence of police officers.

Find your candidate

About your vote

You need to be registered to be able to vote.

If you are not registered visit **www.gov.uk/register-to-vote** or contact your local council.

If you are registered, and eligible to vote you can either vote in person at a polling station, by post, or by proxy (allowing someone you trust to vote on your behalf).

PFCCs are elected using the first past the post voting system, where the candidate with the most votes, wins. Voters will vote by choosing a single candidate on the ballot paper. This is the same system as UK Parliamentary elections.

Dear Resident

I am Martyn Emberson the Conservative candidate for the Police Fire and Crime Commissioner election on the 2nd May.

Election statement:

Labour Candidate for Police Fire and Crime Commissioner Northants.

We have a police service that failed its inspection in 2019. Today, the service still requires improvement in the allimportant category of "Investigating Crime".

We have an under-resourced fire service, with fewer than half of the 28 vehicles available for use most of the time, because crew levels are so low.

Crime figures for the County are shocking. 28% above the national average. Serious violent and sexual crimes have gone up.

We have 1.9 police per 1000 head of population; way under the recommended level of 3.5

Knife crime has become an urgent issue for us to tackle.

The closure of services for families and young people, years of austerity and the cost-of-living-crisis has made that much worse. We have county lines across the county. As one is closed down, another starts up- grooming our children, offering them a way out of poverty.

Danielle will

- Work with multi-agency partners to rebuild community and prevent crime
- Make our streets safer with police back on the beat
- Tackle retail crime, ending the £200 rule which means shoplifters evade justice
- Rebuild trust in services and ensure Fire and Police maintain distinct roles
- Improve response times for both services
- Reduce violence against women and girls with a new perpetrators programme and Domestic Abuse specialists
- Invest in technologies to reduce cyber-crime, fraud, and modern slavery

A life-long community activist, a teacher, education officer and elected Councillor, Danielle will be the people's voice, scrutinising both services, and supporting the improvement journey everyone desperately needs.
