About Police and Crime Commissioners

On 2nd May, you will be able to vote for your Police and Crime Commissioner (PCC). The role of the PCC is to be the voice of the people and to hold the police to account.

Police and Crime Commissioners are elected to hold your police force to account for delivering the kind of policing you want to see. PCCs are responsible for the totality of policing in their force area and aim to cut crime and deliver an effective and efficient police service. PCCs bring a public voice to policing and they do this by:

- Engaging with the public and victims of crime to help set police and crime plans;
- Ensuring the police force budget is spent where it matters most; and
- Appointing the chief constable, holding them to account for delivery of their objectives, and if necessary, dismissing them.

The PCC does not "run" the police force. Chief constables continue to be responsible for the day-to-day operations of the police, but they are accountable to the public via the PCC.

In some Police Force Areas, PCCs are also responsible for Fire and Rescue Services, and are known as Police, Fire and Crime Commissioners (PFCCs). Furthermore, in some areas, neither a PCC nor PFCC is elected – instead there will be an election for a Mayor who will hold the PCC, PFCC or equivalent powers.

37 PCCs will be elected across England and Wales, of which 4 will be PFCCs – PFCCs are found in Cumbria, Essex, Staffordshire, and Northamptonshire.

Work with others

PCCs also work with your council and other organisations to promote and enable joined up working on community safety and criminal justice. As directly elected individuals, they provide opportunities for greater collaboration and effective scrutiny of public services. In doing so, PCCs also have regard to national cross border threats, and ensure there is an effective policing response.

Represent the entire community

PCCs are required to swear an oath of impartiality when they are elected to office. The oath is designed so that they can publicly set out their commitment to: serve all of the people in their Police Force Area; act with integrity and diligence; give a voice to the public; act with transparency so that they may be effectively held to account; and not interfere with the operational independence of police officers.

About your vote

You need to be registered to be able to vote.

If you are not registered visit **www.gov.uk/register-to-vote** or contact your local council.

If you are registered, and eligible to vote you can either vote in person at a polling station, by post, or by proxy (allowing someone you trust to vote on your behalf).

PCCs are elected using the first past the post voting system, where the candidate with the most votes, wins. Voters will vote by choosing a single candidate on the ballot paper. This is the same system as UK Parliamentary elections.

Election statement:

I've been privileged to serve you as Police & Crime Commissioner since 2021. Since then I've appointed the new Chief Constable, delivered record numbers of police officers and we've seen crime at levels well below that prior to the pandemic.

But there's more work to do and whoever you choose as your next Police & Crime Commissioner will need a clear plan and understanding of the challenges ahead. As well as being a strong voice for the public and holding the Chief Constable to account, the Police & Crime Commissioner is responsible for a record budget of over £584m.

 Thames Valley now has 5,120 police officers – over 600 higher than 2010

and compared to before the pandemic, we have seen crime fall:

• Knife crime DOWN by 20.1%

- Residential burglary DOWN by 29.2%
- Robbery DOWN by 23.8%
- Vehicle crime DOWN by 16.9%

In the last year alone I have worked with the police to:

- DOUBLE the number of neighbourhood police officers
- Tackle shoplifting with charges more than DOUBLING
- Continued our zero-tolerance approach to knife possession which sees criminals getting longer sentences

- Visible local patrols



- Taking politics out of policing. The PCC must never be compromised in executing the above remit by any considerations to the polictical stance of his supporting party, either regionally or nationally. The PCC must be seen to challenge the force and not be seen as the force's PR department.
- Driving out corruption from Thames Valley Police (TVP), driving in better police management.
 Corruption to highest levels, including Professional Standards Department (PSD). Officers must be tackled by the PCC, with offenders removed from the force.
 Chief Constable must be challenged with stretching performance targets reportable monthly and publicly.

- **Dignity and justice for sex crime victims.** Non negotiable.
- Protect our communities and shops. Increase police visibility to deter crime and to investigate crime thoroughly and quickly.

Election statement:

For 22 years Tim has worked with police as a prosecution barrister in cases ranging from child sex abuse to drug dealing. He has seen first hand how the system fails people, and what needs to change. Tim says: "Despite the dedication of its hard working officers, TVP is under performing. Recently inspected, it ranked "inadequate" for protecting vulnerable people and "requiring improvement" for investigating crime, responding to the public, managing offenders and leadership.

My priorities:

Rebuilding trust in police by a) strengthening neighbourhood policing, restoring the link between police and the communities they serve, b) overhauling vetting and misconduct procedures.

Cutting knife crime – not youth services. Working with schools and targeted interventions, including 1:1 mentoring to divert young people away from gangs and county lines, and provide positive role models.

Stopping the surge in shoplifting, working with local businesses to identify repeat offenders and ban them from crime hotspots.

Protecting women and girls from violence. Rape cases often take 5 years from being reported to coming to trial, causing many victims to drop out. Fast track sexual and domestic abuse cases, improve the sharing of information with women at risk from a violent partner (highlighted in the recent inspection) and work to change the behaviour of perpetrators.

Keeping us safe online. Online grooming has quadrupled since 2016, whilst Al drives ever more sophisticated scams. Use innovative ways of working with our thriving local tech industry to prevent fraud and keep kids safe.

Keeping all road users safe. TVP was one of only two forces to see a rise in road traffic incidents last year. Through better enforcement and use of third party reporting, TVP can play its part in ending deaths and serious injuries on our roads.
